The literature on the inflation targeting strategy1 highlights four channels for monetary policy passthrough: inflation expectations, the exchange rate, aggregate demand and credit. It is through these channels that changes in the central bank's benchmark rate manage to affect aggregate demand with the objective of achieving price stability.
