In 2023, the Colombian economy experienced a slowdown in economic activity, registering annual

growth of 0.6% after the historical highs experienced in 2021 and 2022. This same year, inflation began to converge to the target, reaching 9.3 % at yearend amid a backdrop of a weakening in domestic demand, lessening upward supply pressures, less pressure from the exchange rate, and a contractionary monetary policy stance.
